Dear Sir/Madam,

In compliance with the provisions of Regulation 30 read with Schedule III of SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015, we wish to inform you that the Committee Members of the aforesaid Committee of the Company in their meeting held today i.e. July 04, 2025 *inter-alia*, considered and approved the following –

- (i) Allotment of 11,82,500 equity shares having face value of Re. 1/- each at an issue price of Rs. 65/- each (including a premium of Rs. 64/- each), consequent upon the conversion of 11,82,500 Warrants issued at an Issue Price of Rs. 65/-each, , to the following persons belonging to the "Non-Promoters/Public Category", on preferential basis, upon receipt of balance amount aggregating to Rs. 5,76,46,875/- (Rupees Five Crores Seventy-Six Lakhs Forty-Six Thousand and Eight Hundred Seventy-Five only) at the rate of Rs. 48.75/- (Rupees Forty Eight and Seventy-Five Paise only) per warrant (being 75% of the issue price per warrant) from the allottees pursuant to the exercise of their rights of conversion into equity shares in accordance with the provisions of SEBI (ICDR) Regulations, 2018 :

Pursuant to members approval, these warrants were allotted, in terms of SEBI (ICDR) Regulations, 2018 to “Non–Promoter/Public, Promoters/Promoter Group Category”, on preferential basis, at an Issue Price of Rs. 65/- per warrant on payment of Rs. 16.25 per warrant, being 25% of the Issue Price, entitling the warrants holders to get their warrants converted into equal number of Equity Shares of the Company by paying remaining 75% i.e., Rs. 48.75/- per warrant within 6 months from the date of warrants allotment.

Consequent to today's conversion of warrants/allotment of Equity Shares, the issued and paid-up capital of the Company stands increased to Rs. 10,58,34,050/-consisting of 10,58,34,050 equity shares of Re. 1/- each.

The new equity shares so allotted, shall rank *pari-passu* with the existing equity shares of the Company.

It may be pleased noted that 28,00,000 total warrants are outstanding for conversion and these warrant holders are entitled to get their warrants converted into equal number of Equity Shares of the Company by paying remaining 75% i.e., Rs. 48.75/- per warrant within 6/18 months from the date of warrants allotment.
